I have been advised that there will be other persons shooting and carrying firearms at the Deerfield Valley Sportsmen's Club (DVSC) and I agree to act prudently and carefully to avoid causing them injury. I certify that I am familiar with the use and operation of the firearm(s) I will be using at the Deerfield Valley Sportsmen's Club (DVSC) and that I am familiar with the rules of shooting and firearms safety.
